Guest Speakers



Amy Bross, RN, MPH is a Nurse Program Manager with the Alliance for Innovation on Maternal Health Program (AIM) at the American College of Obstetricians and Gynecologists in Washington, DC. She has a background working in maternal health in Baltimore City as the maternal health team leader at Healthcare Access Maryland (HCAM), providing direct community health home visitation as well as team leadership for multidisciplinary community health outreach workers providing services to pregnant women and families. Ms. Bross coordinates the maternal opioid use disorder initiative with the AIM program.



Mica Bumpus, MPA, is the Program Director of the Long Acting Reversible Contraceptive (LARC) Program at the American College of Obstetricians & Gynecologists (ACOG). Ms. Bumpus is a health policy and advocacy professional with expertise in women's health and reproductive rights. She founded and currently directs ACOG's Postpartum Contraceptive Access Initiative (PCAI) a

comprehensive training program working to ensure access to the full range of contraceptive methods immediately postpartum. Ms. Bumpus earned a Bachelor of Science in Public Health from Texas A&M University and a Master of Public Affairs with a Concentration in Health Policy from Princeton University.

Laura Campbell, MS, RDN, LDN, CLC is the State Breastfeeding Coordinator at the Tennessee Department of Health.



Laurie DeSantis, CNM, is the Quality and Safety Advisor for Women's Health at Vanderbilt University Medical Center and was the Project Manager for the TIPQC Obstetric Hemorrhage Project. Laurie received her Bachelor of Science in Nursing from Clemson University in 1995 and has worked as both a Labor and Delivery nurse and Mother-Baby nurse. She received her Master of

Science in Nurse- Midwifery in 2005 from University of Maryland and practiced as a Certified Nurse Midwife for 10 years before entering her current position with Quality and Safety.



Victoria DeVito, MD is a neonatologist at Monroe Carell Jr. Children's Hospital. She co-leads the TIPQC Late Preterm Project.



John Dreyzehner, MD, MPH, FACOEM is the 13th Commissioner of the Tennessee Department of Health. Dreyzehner graduated from the University of Illinois at Champaign-Urbana, with a B.S. in psychology. He earned his M.D. from the University of Illinois at Chicago and Master of Public Health degree at the University of Utah, completing his residency, and served as chief

resident at the Rocky Mountain Center for Occupational and Environmental Health. Dreyzehner served as a US Air Force flight surgeon in the 94th Fighter Squadron as well as Chief of Aeromedical Assessment for Air Combat Command. Dreyzehner has more than 25 years of service in clinical and public health leadership at the federal, state and local levels. He is a Fellow of the American College of Occupational and Environmental Medicine, and holds appointments as adjunct faculty and professor (Hon.) with East Tennessee State University's College of Public Health, founding faculty of the Healthy Appalachia Institute and formerly visiting assistant professor of public health at the University of Virginia.



Dmitry Dukhovny, MD is an Associate Professor of Pediatrics and Associate Program Director of the Neonatal-Perinatal Medicine Fellowship at Oregon Health & Science University. He attended medical school at Boston University School of Medicine, completed his pediatric residency at Boston Combined Residency in Pediatrics (Boston Children's Hospital/Boston Medical Center) and

received his neonatal-perinatal medicine training in the Harvard Neonatal-Perinatal Medicine Program. He helped to co-found and now co-leads the regional QI collaborative amongst the 11 NICUs in Oregon and Southwest Washington. He is currently on faculty at the Vermont Oxford Network (VON) for the "Choosing Antibiotics Wisely" initiative and is the VON Fellow Liaison.



Cornelia Graves, MD is the Medical Director of Tennessee Maternal Fetal Medicine and the Director for Perinatal Services at St. Thomas Health Systems; Professor at the University of Tennessee, and serves as clinical and adjunct professor for Vanderbilt University and Meharry Medical College. She is the co-coordinator of the Collaborative Perinatal Cardiac Clinic at St.

Thomas Health. She a graduate of Baylor University; received her medical degree from the University of Arkansas for Medical Sciences, her internship and residency at Vanderbilt University Medical Center. She completed her Maternal-Fetal Fellowship at Vanderbilt University. During her fellowship, Dr. Graves received special training in Obstetrical Critical Care and is a nationally recognized expert in maternal disease states. She is currently a member of the Board of Directors of the Society of Maternal Fetal Medicine, TIPQC Oversight Board and has led the Obstetric Hemorrhage Project.



Zsakeba Henderson, MD is a Medical Officer in the Maternal and Infant Health Branch in the Division of Reproductive Health at the Centers for Disease Control and Prevention. She is a board-certified obstetrician-gynecologist and leads the Division's activities in support of state-based perinatal quality collaboratives (PQCs). She serves as the Division's Liaison to the American College of

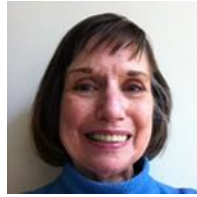
Obstetricians and Gynecologists Committee on Health Care for Underserved Women, and as a physician peer-educator for the Georgia Chapter of the American Academy of Pediatrics EPIC Breastfeeding Program. Dr. Henderson received her BS degree in biochemistry from Oakwood University in Huntsville, Alabama, and her medical degree from Harvard Medical School. She completed her internship and residency at Brigham and Women's Hospital/Massachusetts General Hospital Integrated Residency Program in Obstetrics and Gynecology.



Melissa Kottke, MD is an Associate Professor in the Department of Gynecology and Obstetrics at Emory University in Atlanta, Georgia. She completed a Fellowship in Family Planning and Contraception and is the Medical Director of the Teen Services Clinic at Grady Memorial Hospital. She is the Director of the Jane Fonda Center at Emory, which is involved in research and program development focused on Adolescent Sexual and Reproductive Health. She also serves as the Medical Consultant for the State of Georgia's Family Planning Program.



Tanya Lord, PhD, MPH is the Director of Patient and Family Engagement at the Foundation for Healthy Communities in Concord, New Hampshire. She works with all NH hospitals as they partner with patient and families to improve care. She also consults, teaches, and presents nationally as a patient safety, quality improvement, and patient/family engagement consultant. Tanya earned a Master of Public Health Degree from the University of New Hampshire and a Doctorate in Clinical and Population Health Research from the University of Massachusetts Medical School.



Jeanne Mahoney, RN, BSN is the Senior Director of ACOG's Provider's Partnership, an initiative to enhance collaboration between women's health care providers, public health and other national organizations involved with access to care, promotion of guidelines, and psychosocial issues affecting women's health. In this capacity she directs the multidisciplinary Alliance for Innovation in Maternal Health (AIM), and develops initiatives between ACOG members and partners on maternal and women's health. She came to ACOG from the Massachusetts Department of Public Health where she was involved in coordinating risk reduction programs for women of reproductive age.



Morgan McDonald, MD is the Assistant Commissioner and Director for the Division of Family Health and Wellness in the Tennessee Department of Health. Trained in Internal Medicine and Pediatrics, Dr. McDonald's background is as a primary care physician in vulnerable communities. Dr. McDonald currently facilitates prevention efforts across the state including WIC services, Chronic Disease Prevention, Early Childhood Initiatives, Injury Prevention, Perinatal Regionalization, Newborn Screening, Children's Special Services, and Women's Health/Family Planning programs.



Anna Morad, MD is an Assistant Professor of Pediatrics and the Director of the Newborn Nursery at Monroe Carell Jr. Children's Hospital at Vanderbilt. She graduated from the University of Alabama School of Medicine and did her residency at the Children's Hospital of Alabama. Dr. Morad co-lead the TIPQC Breastfeeding Promotion Project, and is the co-leader of the Late Preterm Project.



Raylene Phillips, MD received a Master's Degree in Developmental Psychology, became NIDCAP certified as an Infant Developmental Specialist, and then attended medical school at University of California, Davis. She completed her pediatric residency and neonatology fellowship at Loma Linda University Children's Hospital in Southern California. She is a neonatologist and Medical Director of Neonatal Services at Loma Linda University Medical Center-Murrieta. Dr. Phillips is an International Board-Certified Lactation Consultant and is a Fellow of the Academy of Breastfeeding Medicine. She is the immediate Past President of the National Perinatal Association and remains on the Board of Directors. Her primary areas of interest are mother-infant attachment, breastfeeding education and support, and Neuroprotective Family-Centered Developmental Care of premature infants in the NICU.



Aaron Shaul, M.Ed. holds a Master's degree in Psychology and is a Learning Consultant in the Learning and Development Department at Vanderbilt University Medical Center (VUMC). Aaron previously worked as a contractor with the United States Army delivering performance enhancement and resilience psychology training to soldiers to help them learn skills faster, perform better under pressure, and maintain confidence in challenging situations. In addition to his work in the military and healthcare sectors, Aaron has developed and conducted peak-performance and teambuilding workshops for individual high school and Division I and III college student athletes.



Ajay Talati, MD is the Sheldon B. Korones Endowed Professor and Chief, Division of Neonatology, The University of Tennessee Health Science Center, and the Director of neonatal-perinatal medicine fellowship. He serves as the Medical Director of the NICU at Le Bonheur Children's Hospital. Dr. Talati completed medical school and Pediatric residency in India and at Henry Ford Hospital, Detroit, MI. He completed a Neonatal-Perinatal Medicine fellowship in 1999 at the University of Tennessee, Memphis. He is a practicing academic neonatologist and the leader of the TIPQC Tennessee Neonatal Antibiotic Stewardship Project, as well as previously led the TIPQC Golden Hour project.



Sarah Taylor, MD, MSCR is an associate professor in the Department of Pediatrics at the Medical University of South Carolina. She received her medical degree from the University of Miami. She then completed pediatric residency and neonatal medicine fellowship at the Medical University of South Carolina, where she joined the Division of Neonatology faculty in 2005. Dr. Taylor's research includes translational investigation into preterm infant growth and bone mineralization, health services research in breastfeeding, and exploration of issues in maternal milk production. She leads the SC Birth Outcomes Initiative Baby Friendly work group and the Safe Sleep Initiative. She also leads the SC Neonatal Nutrition Consortium. At the institutional level, she runs the Children's Hospital Nutrition Therapy Committee and leads the neonatal nutrition quality improvement work. She started the Mother's Milk Bank of SC in 2015 and continues to serve as medical director.



Jessica Young, MD, MPH is Board certified in both Obstetrics/ Gynecology and Addiction Medicine. She specializes in substance use disorders in pregnancy as well as family planning. She leads the Obstetric Drug Dependency Clinic at Vanderbilt Center for Women's Health. Dr. Young leads the TIPQC AIM Opioid Use Disorder (OUD) Project, as well as a Committee Chair for the National AIM OUD project.

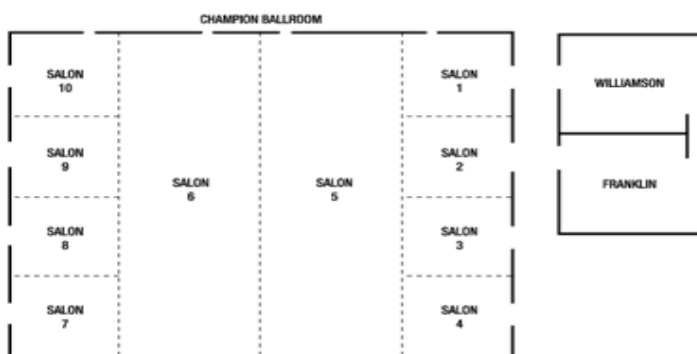

1. **AIM Opioid Use Disorder Collaborative** – State and National Leaders from ACOGs Alliance for Innovation on Maternal Health will discuss the Opioid Use Disorder Project.
2. **Project Kick Off – Optimizing Care of the 35-36 Week Infant in the Newborn Nursery** – Join other teams across the state to develop guidelines and tools to optimize care for this special population, as we kick off this statewide project.
3. **TIPQC Leadership Opportunities**— Individuals interested in leadership opportunities in TIPQC can come learn more about where you can lead and serve our state through TIPQC. All are welcome!
4. **Patient & Family Engagement** – Exciting opportunities to learn from a nationally recognized PFE coach and mentor! Hospital teams are encouraged to send at least one member for each project to learn more about how to engage a patient and/or family in your TIPQC project.
