Bethany Christian Services (Bethany), a national leader in adoption services, vision is that "Family changes everything". Bethany believes that the support birthparents receive during and after their pregnancies is an essential element to adoption. Bethany's pregnancy counseling services support and guide birthmothers in creating a hospital plan, choosing an adoptive family, the court process, grieving their loss, and navigating open adoption relationships. If expectant parents are also considering parenting as an option, Bethany's pregnancy counselor helps connect them with community resources to better equip them. Bethany's Safe Families for Children program focuses on family preservation. When a family is in crisis (i.e. facing homelessness, needing to go to treatment for substance use, facing a difficult medical recovery), Bethany provides childcare through volunteers that Safe Families recruits, screens, and approves (host families (Host Family), family friends, and family coaches). Families in crisis ("Family in Need") willingly place their children with a safe, loving, and thoroughly screened volunteer Host Family temporarily (average - 45 days). Because this is a voluntary program, the Family in Need can reunite with their children at any time. More information on this program can be found on Bethany's webpage, noted above.

Services include, but are not limited to, parent coaching, postpartum depression therapy, stress management, help managing family's physical and mental health needs, fatherhood engagement, breast feeding support, links to addiction related services, infant massage training, and parent support groups.

And addresses some of the unique issues facing chemically dependent women, including prenatal care, childcare issues, parenting concerns, history of trauma (domestic violence or sexual abuse), co-dependency, and other relationship issues.

Tennessee's first Correctional Release Center is The Next Door's Chattanooga location, which offers a unique program in partnership with the Tennessee Department of Correction. Women served by The Next Door in the Chattanooga area are currently incarcerated and receive short-term transitional services that are rooted in evidence-based practices to address their needs.

Other wrap around services include mental health symptom and medication management; food, clothing, and shelter referrals; transportation; parenting training; family and couples counseling; childcare; family planning services and other social services referrals. The Rainbow Program recognizes that women who use drugs face different problems during their lives than men. Research indicates that almost 75 percent of these women report histories of physical and sexual abuse. Societal problems often make women have poor self-confidence, low self-esteem and leave them with a feeling of being powerless over their lives. In addition, minority women may face additional challenges of cultural and language barriers that can interfere their treatment and recovery.

This integrated care model combines physician services (including medication assisted treatment), behavioral health counseling, recovery support services, medication management and patient and family education. Its community-based approach to treatment allows patients to continue working and caring for their families as they overcome addiction. Spero is one of the largest office-based opioid treatment providers in the country and is in network with Medicaid and commercial insurance plans. Physician services—Use of evidenced based practices for the treatment of opioid use disorders that include mental and physical health screenings, individualized recovery plans, and medication management. Behavioral health counseling— Mandatory individual and/or group counseling, activities focused on treatment plan adherence, anti-diversion and developing a recovery orientated lifestyle. Sessions provide safe places to talk and valuable support to help patients achieve lasting recovery. Recovery support services & education—Connections back to the community and skill building assessed on individual patient needs. This can include assistance in finding employment, housing, healthcare, childcare, transportation and more.

ROPS train how to recognize opioid overdose and how to utilize Naloxone - most audiences receive free Narcan from the ROPS after the training.

For pregnant and postpartum mothers, there is a focus on creating an environment empowering the mother to care for her newborn, as well as providing her with any necessary education including education about VLARC and breastfeeding. StrongWell partners with providers and patients to help break the cycle and provide stigma free and loving care to all individuals seeking assistance.

The committee is a multidisciplinary team committed to reviewing maternal deaths, as well as reporting recommendations for changes to laws, rules, and policies that promote the safety and well-being of women and the prevention of maternal deaths. The Child Fatality Review and Prevention Act of 1995 established a statewide network of child fatality review teams in the 31 Judicial Districts of Tennessee. The judicial districts cover all 95 counties of the State. Fourteen Department of Health team leaders provide the administration and coordination of the teams. These multi-discipline, multi-agency local teams have been established in each Judicial District to review all deaths of children seventeen years of age or younger and make recommendations to the state Child Fatality Prevention Team for reduction and prevention of child deaths statewide.
