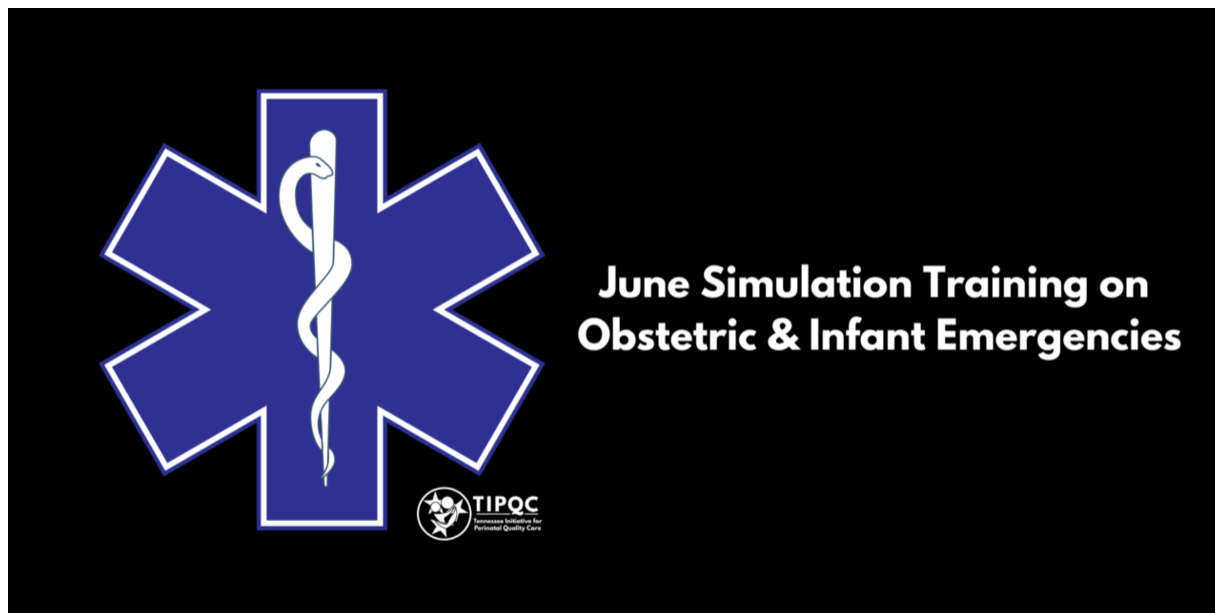

### Report: More than half of all rural Tennessee hospitals no longer deliver babies

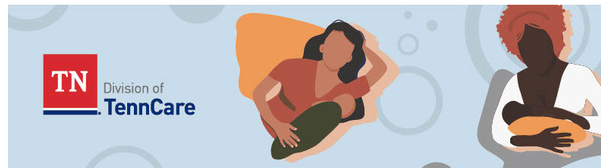
More than half of all rural Tennessee hospitals no longer deliver babies — a trend that shows no clear signs of reversal while pregnant patients outside major metropolitan areas routinely drive an hour, or more, in order to give birth. Just 28 of 52 of the state’s rural hospitals that are still in operation provide obstetric services, according to a new report issued by the Center for Healthcare Quality & Payment Reform. The organization called the constriction of rural obstetric services a “crisis in rural maternity care.” To read more please [visit](#).

#### Are you a Certified Lactation Counselor or Certified Lactation Educator who is interested in providing lactation support to TennCare members?

Starting June 1, 2023, TennCare members are eligible for outpatient lactation consultation benefits during pregnancy and postpartum.

Lactation support can be in-person or via telehealth in a 1-on-1 or group setting before childbirth and after delivery.

##### How does it work?

CLCs and CLEs can provide lactation support services to TennCare members as an employee of an in-network practice or group while under the supervision of a registered, in-network TennCare provider.

Authorized supervisors of lactation services include in-network MDs, DOs, NPs, PAs, certified nurse midwives, and IBCLCs. Supervision can be off-site or remote.

#### Are you an International Board-Certified Lactation Consultant who is interested in providing lactation support to TennCare members?

Starting June 1, 2023, TennCare members are eligible for outpatient lactation consultation benefits during pregnancy and postpartum.

##### How Does it Work?

International Board-Certified Lactation Consultants (IBCLCs) can join the TennCare network of providers and be reimbursed for lactation support provided to members.

In-network IBCLCs can be reimbursed for telehealth and in-person lactation support provided in a 1-on-1 or group setting before childbirth and after delivery.

##### If you're interested in becoming a TennCare provider, follow these steps:

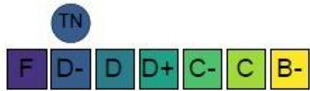
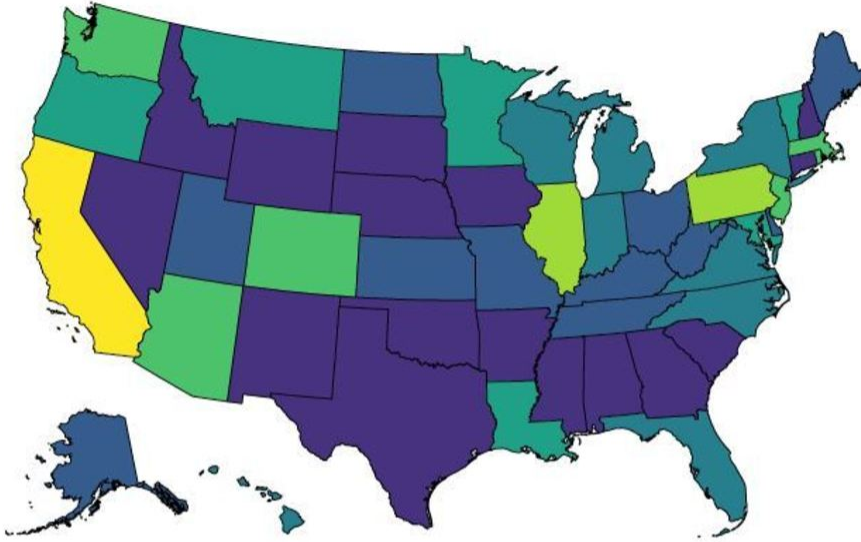


## First Ever Maternal Mental Health Report Card
